# HOW DO I JOIN THE ARCHIVES CURATORS SOCIETY?

When you complete the attached commitment form indicating you have or plan in the near future to make a legacy gift, you are automatically enrolled in the Society. Legacy gifts are arranged now but realized in the future as part of your estate plans. The most common legacy gift is a Bequest of cash or property in your Will or Trust.

## YOUR CHARITABLE BEQUEST

A Will is perhaps the most important document you can have. It is critical to making sure your wishes are carried out exactly as you desire. Your charitable bequest can either be Specific or Residual.

A Specific Bequest is a gift of a specific dollar amount or an asset such as personal property, real estate, a collection or an account.

**Sample Specific Bequest language:** "I give, devise, and bequeath to the Science of Mind Archives and Library Foundation, 573 Park Point Drive, Golden, Colorado 80401, Federal Tax ID number 56-2676731, *the sum of (\$ \_\_\_\_\_ ) or (Specific asset such as "my personal residence located at \_\_\_\_\_"),* to best promote the objectives and mission of the Foundation."

A Residual Bequest is distributed after all of your estate's expenses and specific bequests are honored. In this way you can be assured all your beneficiaries are treated fairly and your wishes are honored, no matter what the value of your estate may be.

**Sample Residual Bequest language:** "I give, devise, and bequeath to the Science of Mind Archives and Library Foundation, 573 Park Point Drive, Golden, Colorado 80401, Federal Tax ID number 56-2676731, ( \_\_\_\_ %) of the remainder of my estate, to best promote the objectives and mission of the Foundation."

## BENEFICIARY DESIGNATIONS
