If you are age 70 1/2 or older, you can make a gift directly from your Individual Retirement Account (IRA) to the Science of Mind Archives and Library Foundation.

These gifts called *Qualified*



Charitable Distributions, can count toward your *Required Minimum Distributions* if you have reached the age when you must take funds from your IRA. You can make a

gift of up to \$100,000 per year by making a request through your IRA administrator.

Making a gift to the SOM Archives directly from your IRA will eliminate the federal income tax that you would normally pay. For this reason, "IRA QCDs" do not qualify for a federal income tax charitable deduction.

Arrange a Beneficiary Designation

At any age, you can designate the Science of Mind Archives and Library Foundation as the final beneficiary of many types of financial accounts, including IRAs. You can arrange this by completing a beneficiary designation form provided by your administrator.

The Science of Mind Archives is not subject to the income taxes that would otherwise be paid, and beneficiary designations can be changed at any time—making retirement accounts an advantageous way to arrange a future gift without a will or trust.

There is no minimum or maximum amount for this type of gift, but if you are married, spousal approval may be required when changing beneficiaries.
